

Vik $\ensuremath{\textit{Ørsta}}$ M16 rebar bolt is threaded 300 mm and has a bevel cut at the other end.

Used for hanging PE / insulation vault / membrane.

Product specification

We have our own production in Norway and use high quality

Norwegian-produced recycled reinforcing steel. The steel is hot-dip galvanized and powder coated (CombiCoat®) to achieve 120 years of corrosion protection

(ref.: SINTEF research report based on laboratory testing in collaboration with Vik Ørsta AS)

All of our rock support bolts is produced according to NS-EN 1090, delivered CE-approved and follows the requirements of Norwegian Public Road Administration (Statens Vegvesen) handbook 761.

The bolt is delivered with nut.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. 
